Basketball Tournament Rules & Waiver Form

Event Logistics

Hosted by Geneseo Rotary as part of the annual Summer Festival our 3-on-3 Basketball Tournament will be held on Friday, July 7th and Saturday, July 8th on Center Street in Geneseo. Younger age groups will play on Friday and older groups on Saturday. Games will begin at 10am and run until about 3pm. Game time slots will be 30 minutes each and run consecutively. Teams must be on the court ready to play at the start of their time slot. If all team members are not ready to play within 5 minutes of the starting time, the team will forfeit. Games are played to 21 points or 20 minutes of running time, whichever comes first. The tournament will be double elimination.

Teams will compete within grade divisions for each tournament bracket based on the school grade they are entering for the Fall 2023 school year. Team members can move up a grade division if desired, but cannot play at grade divisions below their own grade (i.e. an 8th grader can play in the 9th & 10th division, but not in the 5th and 6th division). Shoes and shirts are required for all participants. No dunking or hanging on the rim allowed, as the basketball hoops are freestanding and not designed to hold the weight of a person.

Event coordinators will have basic 1st aid kits on hand, but will not have any advanced medical equipment on site. Please notify event staff of any pre-existing medical conditions prior to play. Restroom access will be available nearby. It is recommended that participants and spectators bring their own water and lawn chairs. Parking will be available in the adjacent municipal lot for the event.

Deadline to register is July 5th. You must complete the google form and submit your \$100 team registration payment either in the form of a check made out to Geneseo Blue Knights Softball or via Venmo to Event Coordinator Julie Bennett @julie-bennett-49.
